Miss Fulton County 2023 • Year of Service Terms •

By competing for the title of Miss Fulton County at our local competition, you agree to be bound by the terms in this document.

If you win a title at our competition, your Year of Service will start the moment you are crowned and cease when you crown your successor unless we agree to other terms in writing.

1. Appearances. Any time you present yourself to others using your title is an "appearance." Appearances include, but aren't limited to, in-person meetings, gatherings, presentations, television or radio appearances, social media posts, and parades. Any time you appear as a titleholder, you must have our permission.
 - a. Required Appearances.
 - i. Titleholders' Welcome Meeting
TBD (usually the morning after the competition).
 - ii. Visits to specific gift and scholarship sponsors as determined by the organization
 - iii. The 2023 Miss New York Workshop
Mid-March; TBD
 - iv. The 2023 Miss New Competition/State Week
May 30–June 4, 2022; Peekskill, NY
 - v. A group photoshoot by Viscosi Photography

 - vi. The 2024 Miss Fulton County Competition, including all workshops and rehearsals, TBD
 - b. Other Appearances.
 - i. If we arrange additional appearances for you, they will be optional. We will try to provide notice at least 72 hours before the appearance. Once you have committed to attending an appearance, we expect you to attend.
 - ii. You are encouraged to set up appearances yourself. We will be happy to allow and facilitate these appearances but reserve the right to determine whether you may attend.
 - iii. For appearances you plan, at a minimum, we require that you have permission from the event organizer or location owner and a plan to promote our organization, your social impact initiative, or some other charitable or social cause. You must provide at least 72-hours' notice of any appearance you wish to attend.

- c. Social Media. You must maintain social media accounts provided, monitored, and owned by the organization.
 - d. Appearance Wardrobe.
 - i. Your wardrobe for each appearance must be appropriate for the occasion. We may require that you get our approval of your wardrobe before each appearance.
2. Fundraising. We encourage you to use your title to raise money for your social impact initiative or other worthy cause. All fundraising events you attend or plan must be cleared by the organization. If you use your title, crown, and sash to raise money, you must give 10% of the proceeds you raise to our scholarship fund.
3. State Preparation & Expenses.
- a. We will pay or provide the following:
 - i. participation fees, but not fundraising fees, imposed by the MNY Agreement
 - ii. lodging, if required, to participate in the state competition and workshops
 - iii. any competition wardrobe items required by the state board
 - iv. compensation for travel to and from the state competition and workshops
 - v. headshots with our official photographer Viscosi Photography
 - b. At your request, we will also provide the following:
 - i. help with state paperwork preparation
 - ii. mock interviews
 - iii. walking practice
 - iv. help with state-choreographed dance routines
 - v. help and coaching with talent preparations
 - c. You must do the following:
 - i. meet all deadlines imposed by us or the state board
 - ii. consult with us in selecting your state headshot
 - iii. prepare your state paperwork at least one week before the state deadline to allow us to review and comment
 - iv. consult with us on your competition wardrobe
 - v. consult with us on your state-week wardrobe

It is our sincere hope that you enjoy your year as a titleholder. We encourage you to communicate with the executive directors and board members often. We are here to make your year rewarding for both you and the organization.
